still, this possibility does not deter me from preparing the letters as a continuation and expression of my thoughts concerning all matters and events pertaining to our separation.


Care is an expression of love in a sense, and usually includes tending to one's needs and comfort as well as being conscience and sensitive.





Esther was placed in this powerful role by providence; she was serving God by ensuring that her people (the Jewish captives) were not destroyed by evil leaders among the King's court.


God in his patience and mercy, has allowed me to once again worship and serve him – I am fortunate!
